Section 2648.3, subdivision Cd), allows for an extension of the hearing date upon a showing of good cause.

Pursuant to the Notice of Hearing filed by the California Department of Insurance on March 17, 2025, Applicant State Farm General Insurance Company filed Rate Application Nos. 24-1271 and 1273 on June 27, 2024; the Applicant waived thereafter waived the "deemed approved" dates set forth in Insurance Code section 1861.05, subdivision (c), on September 3, 2024.

Pursuant to the Notice of Hearing filed by the California Department of Insurance on March 17, 2025, Applicant filed Rate Application No. 24-1330 on July 5, 2024; the Applicant waived thereafter waived the "deemed approved" dates set forth in Insurance Code section 1861.05, subdivision (c), on September 10, 2024.

The ALJ will schedule the evidentiary hearing for the earliest convenient date.

Meet and Confer

The parties shall endeavor to meet and confer prior to the Conference to discuss a proposed evidentiary hearing commencement date, as well as the matters listed under
