JOINT STIPULATION AND [PROPOSED]
ORDER FOR DISMISSAL OF ENTIRE
ACTION WITH PREJUDICE

Plaintiffs Paul Simon, Jane Doe and Jane Roe, Lee Fintel, Leonardo Costello, Melissa Wallace, Lynelle Goodreau, Rebecca Porrino, and Bonnie Shulman (hereafter "Plaintiffs") and Defendant Blue Cross of California dba Anthem Blue Cross ("Anthem") (collectively, the "Parties") submit the following Stipulation:

Plaintiff filed the above referenced case as a class action on October 31, 2016.

On July 19, 2018, the Court granted Anthem's Petition to Compel Arbitration. As part of the Order, the Court also enforced the class action waiver provision, which prohibited Plaintiffs from participating in class or representative proceedings as to all disputes between the parties.

On November 1, 2019, the trial court's decision to grant Anthem Blue Cross's petition to compel arbitration, enforce class action waiver, and stay case was upheld in full by the California Court of Appeal.

Therefore, the only remaining claims in the action were the individual, non-class, claims brought on behalf of the eight named Plaintiffs.

Prior to initiating arbitration proceedings, the Parties reached a settlement of each of the eight individual claims, thereby resolving the action in its entirety.

On October 15, 2020, the Parties filed a form Request for Dismissal with the Court, but the Court rejected the Request for Dismissal. The reason provided was as follows: "This form may not be used to dismiss a class action or any party or cause of action in a class action."

Accordingly, the Parties have filed the instant Stipulation for Dismissal to clarify that the only remaining claims in this action were the eight individual, non-class claims, which have been fully resolved.

Therefore, the Parties, through their respective counsel of record, hereby stipulate and agree that this action shall be dismissed in its entirety with prejudice. Each Party is to bear its own attorneys' fees and costs except as separately agreed.
